c. Treasurer:

- 1. We will get numbers after the 15th.
- 2. The budget is being prepared for 2019.

d. Architectural Control Items:

- 1. The wheelchair ramp waiver was registered with land records.
- 2. Allison Camillo resigned from her Board position. Laurie Dickson will take over the vacated architectural control chairman duties.
- 3. A homeowner submitted a request to add a portico to their front door. The Board voted to approve.
- 4. A homeowner submitted a request to replace their existing fence with a new fence. The Board voted via email July 17-18, 2018, and the request passed.
- 5. A homeowner submitted a request to paint their siding, trim, front door, and shutters. The colors would remain the same except shutters will be black. The Board voted via email July 14-17, 2018, and the request passed.

e. House and Grounds Items:

- 1. The grounds issues are still being addressed with our landscape company. Pictures were taken of our grounds and emails sent to company. Board wants to approve the invoices before being paid.

- 3. HV lock/gate needs realigning.
