b. November 7, 2018: Secretary, Laurie Dickson, read the minutes. The minutes were approved as read.

#### c. Treasurer:

- 1. Renewal is due for liability insurance for \$1,476 which covers Board of Directors & CMA. New company is Continental Casualty.
- 2. 10% needs to be moved to reserves.
- 3. Melissa will get budget updated and sent to CMA.
- 4. Legal fees have trended up due to monitoring of bankruptcy and back fees.
- 5. Hayley will call Elina, the lawyer, to discuss fees.

#### d. Architectural Control Items:

- Paint request by homeowner- Board did not approve colors. The colors were pretty but couldn't visualize dark trim and light colored shutters. Asked homeowner to show picture of another house for an example.
- 2. New build request in HII- owner of the lot sent pictures to the Board to approve of the house they would like to build. The Board needs more details.

## e. House and Grounds Items:

- 1. Private Landscaping contract is terminated at end of 2018.
- 2. Justin met with Dutch, owner from Garden's Edge. New contract should begin 1/1/19. Justin is going through the contract to make sure all looks good.
- 3. Board voted on 1/7/19 to execute the contract for Garden's Edge after concern about contract/pricing.
- 4. Christmas wreaths will go up this weekend 12/9/18.
- 5. Board voted and approved for trees at HIII entrance and tennis court to be removed for \$2,250.
- 6. Board voted and approved for 550 bales of pinestraw @\$3,300 to be distributed along the grounds areas on 12/17/18.

### f. New Business:

- 1. The Board discussed and voted that Mabry Oaks should pay- 2019 annual dues (\$4,865), payment of ½ annual dues (\$2,432.50), and payment of 100% all attorney/legal fees & county filing fees.
- 2. Jay will get questions for a survey compiled regarding the Hedgerow III tennis courts.

## g. Old Business:

- 1. The Board voted for option 1 for the magnet design. Made minor changes and bolder lettering.
- 2. The Board approved a \$10 charge for Jay to get a prototype made of a magnet before ordering.
